The clerk noted there was strong support within the township for recycling services. The supervisor said he would contact NCD about the potential cost of continuing a recycling program in the area.

# B. Polling Location safety

As a state judge had recently blocked the enforcement of an open carry ban at polling places across the state, the clerk requested that the board consider amending its policy, under section 5.3, titled "Safety" to prohibit open carry of any type of weapon in the township hall, either entirely or at elections. She was concerned about voters feeling safe at the polls and the risk from firearms or other weapons being allowed in a local government facility (and noted that they are prohibited from all county buildings). The board took no action on this matter.
