- (a) Place the application in an envelope and deposit it in the United States mail, another mail service, parcel post service, or common carrier. You may return the application by fax or email (onotatwp@tds.net), as long as your signature is visible.
- (b) Deliver the application personally to the clerk's office, to the clerk, or the clerk's authorized assistant.
- (c) In (a) or (b), a member of the immediate family of the voter* or a person residing in the voter's household may mail or deliver the application for the applicant (*includes grandparent, grandchild, father-in-law, mother-in-law, brother-in-law, sister-in-law, or daughter-in-law).
- (d) If an applicant cannot return the application by any of the above, they may select any registered elector to return the application.
